Welcome and Introduction			
Janie C Munro (JCM), Chair of the Glasgow Parent Council Forum, opened the meeting by offering thanks to all present for attending.			
JCM explained that the first half of the meeting would be for the annual report, changes to the constitution, committee formation and appointment of a new chairperson. This would be followed by General Business.			
JCM read out the Annual report from the Committee and noted that Baillie McFadden, GCC's new Education Convener would be sixth Education Convener in the four years of the GPCF.			
There were no <u>New Resolutions, Changes to the Constitution and Standing Orders</u>			
Committee Formation			
JCM told the meeting that she was standing down as Chair of GPCF as her youngest son has now left school. She also noted that Gary Johnston had resigned from the Committee as he has left the country.			
Kate Cunningham (KC) has been acting as Interim Chair since JCM stood down in June. KC was then confirmed as Chair.			
Existing members will remain on the Committee as follows: Nancy Loftus (Cardonald Primary and Rosshall Academy), Joanna Murphy (St Bride's Primary and Holyrood Secondary), Anne McTaggart (Blairdardie Primary), Mandy Running (Lourdes Secondary), Ahmed Owusu (St Constantine's Primary),Emma Mcintosh (Westercommon Nursery and Ruchill Primary) Richard Porter (Barmulloch Primary and Springburn Academy) and Bruce Whyte (Kings Park Primary).			
New members were: Mike Connolly (St Thomas Aquinas) and Suzanne Millar (Notre Dame Primary)			
JCM thanked all of the above for their willingness to be involved and confirmed that they are now committee members.			
Those present then offered their sincere thanks to Janie for her outstanding contribution to education in Glasgow.			

Maureen McKenna (MMK), Glasgow City Council's Director of Education then took the floor to address the issues raised.	
Triple P Parenting The floor raised questions about the future of the project as their phone line was not being answered. MMK resp0nded that due to the disappointingly low turn out to the school based seminars the decision on the future strategy would be made shortly. Kathryn Farrow (KF) said that she would be willing to run a seminar for a school which could guarantee a turnout of at least 12 parents.	
Tuck Shops MMK asked the floor the nature of the concerns about the introduction of school tuck shops. Responses included: lack of parental consultation; the contradiction between parents guidelines for snacks and lunch boxes and the items on sale; lack of ingredients on packaging.	
MMK responded to say that this was not an issue on which she felt it was necessary to consult with parents as all the items on sale came under the nutrition legislation. She said there were concerns that tuck items were being sold alongside lunches which contravenes the policy and that she would investigate the lack of ingredients on packaging. The floor raised concerns that often only sandwiches were available instead of hot option. MMK would like examples of this so that Cordia can investigate.	All
It was agreed to ask Cordia to address a future GPCF meeting.	All KC
MMK expressed concern that the implementation of the 50p charge for the breakfast club had seen a drop in take up. She told the meeting she may consult on starting the service earlier and increasing the charge to support working parents. She told the meeting that in some schools they have set it up as a Friendship Club in areas where multiple ethnic groups exist (and possibly deprivation too) to promote friendship, the 50p charge has been removed as a grant has been obtained	KC
EAL Provision MMK confirmed that the Primary Language Unit has now closed. This is because it took only 100 children out of the 500 children Glasgow takes into its schools who require this support. Children from P1-P3 go straight into class but those in P4 to P7 who require ESL support. The Unit teachers have been deployed into the peripatetic team which is allocated according to need. However the number of children requiring ESL support is increasing while the number of teachers remains the same and is also vulnerable to cuts.	
Policy on Supply Teachers MMK explained that she would very much like not to employ retired teachers to provide supply but that the Equalities Act makes such a policy impossible. It is also the case that newly qualified teachers rarely want one or two days teaching and prefer to hold out for longer contracts	
School Libraries Concerns about the closure of school libraries had been raised and MMK explained that limited scope for professional development coupled with the fact as support staff, school librarians were eligible for the early retirement package which some took. This led to discussions with Glasgow Life on providing a service to schools based on need.	
Every secondary will retain its library but very few will have a full time librarian. This is felt to be the best delivery model based on roll and need.

Scottish Government's budget will be cut by £3.7 billion or 12.5% over the next spending review period until 2014 to 2015 Reductions will be largest in 2011 to 2012, £1.7 billion in real terms Budgets may not return to the 2009 to 2010 level until 2025 to 2026 If Health spending is held constant, the non health element will reduce by 20.2% 2014 to 2015
